CUMBERLAND COUNCIL REVERSED ITS BOOK BAN

42,480 PEOPLE SIGNED OUR PETITION!

When Cumberland Council in Western Sydney banned books featuring same-sex parents from its libraries, Equality Australia teamed up with a local resident and proud grandmother to a rainbow family, Caroline, to call on the Council to reverse the ban.

A groundswell of support for the LGBTIQ+ community, spearheaded by Caroline, was one of the biggest displays of mass public support in Equality Australia's history and, combined with intensive political engagement behind the scenes, it overturned the ban on books featuring rainbow families in the Western Sydney council's libraries.

We don't ban people or families. Our diversity is part of what makes living in our area so special. We are better than this motion.

22 VOTES FOR, 4 **NSW BAN ON CONVERSION PRACTICES**

NSW became the latest state to ban conversion practices, passing the Conversion Practices Ban Act 2024 (NSW).

AGAINST

Equality Australia delivered countless briefings with MPs behind the scenes, worked with brave survivors who told their stories publicly and ensured survivor's voices were heard in developing the NSW Government's legislation.

On the night the bill passed into law, the team at Equality Australia joined survivors at NSW parliament, camping out overnight as the debate continued. The bill passed with 22 votes to four in the upper house and saw NSW become the first state to legislate in this area with multi-partisan support.

Conversion therapy only teaches us to hate ourselves. By banning it in NSW, we've saved so many people's lives.


ONE STEP CLOSER TO BEING **COUNTED IN THE CENSUS**

In 2021, the census failed to count us and our families. April Long was made to feel that their family was invisible in the last census and filed a human rights complaint with Equality Australia against the Australian Bureau of Statistics. The census kept asking for April's son's father - he has two mums.

Following the conciliation and settlement of the complaint, not only did the ABS issue a statement of regret in August 2023, but April, Equality Australia and representatives across our communities were included in conversations advising the ABS on how to best include our communities.

The 2021 census left my family uncounted, my partner and I excluded as parents, and our son's family invisible. Every individual, parent, child and family deserves to be counted. I look forward to the 2026 census when we can finally tell our son how many kids like him have two mums. - APRIL LONG

Update: In August 2024, after a shock announcement by the Federal Government that it had decided not to add any new topics to the Census, we worked furiously to reverse the decision, resulting in the Government deciding to add questions on sexual orientation and gender identity.



LAUNCHED OUR LANDMARK REPORT ON RELIGIOUS DISCRIMINATION AT PARLIAMENT HOUSE

1,000+ MEDIA MENTIONS IN ONE DAY

After years of meticulous research, Equality Australia released its ground-breaking report, *Dismissed, Denied and Demeaned*, documenting the extent of LGBTQ+ discrimination in religious schools and organisations across the country.

Equality Australia announced the report's release at a press conference at Parliament House in Canberra, alongside Karen, a teacher, and James, a former student, who both endured discrimination.

The story made national headlines with more than 1,000 media mentions in one day, bringing the issue of discrimination into the mainstream, and providing a roadmap for reform by federal and state governments.

NSW EQUALITY BILL INTRODUCED

MORE THAN 500 LAWS AUDITED

Equality Australia audited more than 500 laws for discrimination against LGBTIQ+ people. This helped form the basis of the Equality Bill, which was introduced in August 2023 and remains our best shot at long overdue reforms that affect our communities every day. We have called on our community to contact MPs with messages and put up targeted outdoor posters across Sydney, and continue to meet with parliamentarians and government to advocate for change.

The Equality Bill would better protect our communities from family and personal violence, improve recognition of children born through surrogacy and ensure trans and gender-diverse people can update their birth certificate without unnecessary surgery or medical treatment.

Misaligned birth certificates and documentation cause constant and deep frustration - I am misgendered constantly by every automated system that pulls from a birth certificate for ID in NSW, and often am forced to out and explain myself, with the whole process being demeaning and dehumanising every time. Every time I have to get my license redone, or the car registered, or even collecting medications I'm getting the "MISTER Stephanie".





WORKED FOR #TRANSEQUALITY WITH THE COMMUNITY AND IN PARLIAMENT

In August 2023, Equality Australia launched TransEquality, a dedicated initiative to bolster the capabilities, connection and rights of trans and gender diverse people.

We held our inaugural TransLeading workshop – where 15 up-and-coming trans leaders took part in our leadership and capacity building program. Participants walked away as friends and with tools to inspire change in ways that are authentic to them.

We helped defeat five motions across federal and state parliaments attempting to restrict access to gender affirming care and, in one instance, seeking to criminalise doctors who prescribe it.

Transleading was an awakening for me. Gave me what I needed to be able to navigate my blocks and start getting some of my ideas into the world.

TWO STATES MADE UPDATING BIRTH CERTIFICATES POSSIBLE!

Last year, the Queensland parliament passed a law allowing trans and gender diverse people to update their ID without surgery. In May this year, these life-changing reforms came into effect, introducing best-practice, respectful pathways to gender recognition.

For most of us, our birth certificate is the first piece of identification we have, and for many young people, it's their only proof of identity.

Until recently, Western Australia was the only state with a 'Gender Reassignment Board' - a board of strangers who decide if someone could legally change their gender. It was a process described as 'humiliating and dehumanising'. But in April this year, the WA Government introduced a bill that will abolish the Gender Reassignment Board and recognise non-binary people for the first time.

I have lived as a man for 11 years. I promised myself I'd never go before the Board and feel the shame of 'proving' myself. I'm glad I never had to break that promise.

SUPPORTING THE VOICE

22 LGBTIQ+ GROUPS JOINED THE STATEMENT

We partnered with BlaQ Aboriginal Corporation to bring together the LGBTIQ+ community and show our support for the 'Yes campaign', as the country prepared to vote on whether an Aboriginal and Torres Strait Islander Voice should be enshrined in the Constitution. We mobilised our supporters, ran a community event and commissioned a beautiful artwork from Aboriginal artist Wayde Clarke (Alejandro Lauren) that was shared widely. It was an inclusion flag comprised of journey lines and meeting places to symbolise the importance of inclusion and recognition.



I wanted to bring Australia and everyone's journey into the artwork, into all the different colours, just to make it inclusive because a world that has inclusivity is a world that I want to live in.






HOW WE DID IT: FY2024 FINANCIAL OVERVIEW


